Good morning. I am sorry for the delay in responding to you about the information concerning the Challenger transcripts.

But for me and for the others, it is not as simple as it would seem. We left a lot of ourselves behind when the accident happened. We struggled to maintain ourselves after we “died” and we worked hard to understand the phenomenon of channeling as it was explained to us in those first few weeks.

Unfortunately, we did not live in a very honest world, and so our intent – and the intent of those left on the earth plane – was scrambled for more reasons than is necessary to explain. Let’s just say that what is done is done.

But – and for the record – you guys in FMBR need to complete this step in order for everyone to be free and clear. It doesn’t matter if the material is seen by a few hundred or a few thousand. It just needs to be available for the completion of this cycle. Like anything that is made public, there are always areas within the material that need to be tweaked. It doesn’t mean that removal is dishonest and that is what I fear FMBR is concerned about. But in the real world it is important to edit and redirect so that the full impact of the material can be seen in the most favorable light.

Why is this important? Because this is 30 years plus in the making and that is a most full and complete cycle. As a scientist myself, I understand the need to know as much as possible. But from this side of the veil I also understand that some things will never be completely understood and that is as it should be. To try and scope things out so completely means the ego has to transfer prejudices and incomplete wisdom into something, thereby changing the circumstances and the importance of the original intent. Some things are just better left alone and unsaid.

As a woman and an astronaut and a scientist, I am very well aware of trying to feel obligated to leave no stone unturned. However – and this is very important – scientific thought and construction often leaves out some of the most important details... that of the observer who has no prejudice of what things should look or feel like. To look openly with the most unattached eye is the hardest thing for any human being to do... regardless of standing in the outside world or the drama of responsibility. I stand with the others... publish the damn stuff but do not stand on the scientific shelf which says we cannot move one dotted “i” or crossed “t” out of the material. The bigger picture needs to be seen here.

Jeanne and Regina had many years to process the result of this channeling. The things that took place in their lives wasn’t all about the Challenger material and the government knowledge of this material. It was also very connected to the other part of their story... the work that they originally came in to do. Because the powers that be “saw” them, their identities had been discovered. Unbeknownst to them it would have happened sooner or later.

Our communication with them over the years was just the tip of the iceberg and the intrigue and espionage goes far deeper than our work with them or FMBR. Someday Jeanne will be able to write about it, but some of it... but some information must still remain quiet. She knows this all too well and that is why she has been so quiet about it. The integrity of the work must not be compromised.

And so, as I am writing through her today, I would suggest that you are all fully aware of what the responses are within you about this material... the excitement, being wary and perhaps concerned that there still may be strong outside forces which could bring harm to all who are connected to this project.

Jeanne and Regina have had to face, remove and heal all the trauma because of the work. There are excellent ways to face the personal fear-devil and to remove it. The importance of this stands because that is how the world order is right now. The world order is one of fear-based energy. This is the technology being used for control. In order to do yourselves justice, the responses you are feeling are important... they must surface in order to be seen and cleared.

Jeanne, Regina and their powerful spiritual group have already taken steps to clear any fear or trauma around this channeled material. As the other side of the page handling this material, it is important for you (FMBR) all to weed out any remaining fear that you may have, so as not to attract fear to the project.

This is all in order. We are aware of this coming up and we are on the other side cheering you on. I cannot personally guarantee that there won't be some issues. But I can guarantee that Jeanne is ready and willing. I can't speak for Regina because at this time I am connected to Jeanne and I am very well aware of her process and what she is willing to do. I have to admit that there has been a bit of fear and trepidation from our side too. But we have reason to be this way as we are really connected to our human personality side right now. That is how we can speak to this.

So, in closing, I guess that I must wrap up this "transmission" with the statement... Never walk farther than you can see, but trust that the inner light can go much farther than the human mind. Trust that you can remove self-doubt, fear and concern – all with the understanding that you will seek the higher ground in all of this and become more than the scientific community pursuing some very interesting phenomenon.
